One from R & R Fire Truck Repair, Inc. and the other from Emergency Vehicles Plus. Motion by Paterek seconded by Swiacki to allow Fire Chief to pursue ambulance purchase from R & R Fire Truck Repair Inc., which has the better warranties for the Duramax 6.6 Liter Diesel Chassis of 2016 GMC G-4500 for \$152,368 with the understanding that there will be additional charges between \$15,000-\$17,000 for radios and graphics. Transfer of \$175,000 from AccuMed Account to new line item in capital outlay purchase of ambulance as amended.


