Dave would like to go with the next contractor, as they are not getting anywhere. Spalding DeDecker contacted James Pieprzak asking if they were willing to hold the initial bid with recommendations. Mr. Pieprzak indicated that a flow meter needs to be added (approx... \$59,000) to the bid and indicated the use of PVC909 to save money for the water main instead of iron piping. Estimated cost would be roughly \$1,100,000.
