

TOWNSHIP OF ARMADA  
ORDINANCE No. R-2011-13

An ordinance to amend the title and certain section of A-9 "Emergency Medical Services" of Appendix (A) of the medical services received by those in confinement by or at the direction of the Township.

**Section 1.** Sec. A-9 of Appendix A of the Armada Township code entitled "Emergency Medical Services" shall be modified to update the Township fees and charges for certain medical services provided to persons incarcerated or transported by, the Township, which shall read as follows:

**Sec. A-9(a). Emergency Medical Services**

The following fees shall be assessed to and paid by any person utilizing the services of an emergency vehicle owned or operated by the Township for purposes of transporting that person to a facility for emergency medical treatment.

**Sec. A-9 (b) Medical Treatment of those confined**

Any person held in custody, confined or incarcerated by the Village/Township/County including but not limited to: individuals who are i) under arrest, ii) incarcerated iii) imprisoned, iv) escaped from confinement, v) under supervised release, vi) on medical furlough, vii) residing in a mental health facility or halfway house, viii) living under home detention, ix) or confined completely or partially in any way under a penal statute or rule; shall be solely rendered to, and received by that person during the course of his or her confinement with the Village/Township/County, or at the Township's or Court's direction, including without limitation, transportation to and from a medical treatment facility, and any

treatment deemed necessary by his or her treating physician, whether or not requested by the prisoner; and shall be required to reimburse the Township, in full for any fees or charges incurred for such services, if not paid directly to medical facility or practitioner by the prisoner or his or her insurance carrier.

**Section 2. Saving Clause.** Nothing in this Ordinance or in the Code hereby adopted shall be constructed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any caused or causes of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired or affected by the Ordinance.

**Section 3. Severability.** Should any word, sentence, phrase or any portion of this Ordinance be held in a manner invalid by any court of competent jurisdiction or by any state agency having authority to do so for any reason whatsoever, such holding shall be construed and limited to such work, sentence, phrase or any portion of the Ordinance held to be so invalid shall not be construed as affecting the validity of any of the remaining words, sentences, phrases or portions of the Ordinance.

**Section 4. Conflicting Ordinance.** All prior existing ordinance adopted by the Township of Armada or inconsistent or in conflict with the provisions of the Ordinance are, to the extent of such conflict or inconsistency, hereby expressly repealed.

**Section 5. Publication.** A true copy of this Ordinance or summary thereof shall be published in The Armada Times, a newspaper of general circulation in the Township of Armada.

**Section 6. Effective Date.** This ordinance shall take effect thirty (30) days from and after publication of a true copy in The Armada Times, as provided by Section 5.
