**ORDINANCE DESIGNATING AN ENFORCING AGENCY FOR THE
STATE CONSTRUCTION CODE**

ORDINANCE NO. 06-02

TITLE

AN ORDINANCE of Armada Township to designate an enforcing agency, specifically the building official, to discharge the responsibility of the Township of Armada, under the provisions of the State Construction Code Act, Act No. 230 of the Public Acts of 1972 as amended, commonly known as the Stille-Derossett-Hale Single State Construction Code.

THE TOWNSHIP BOARD OF THE TOWNSHIP OF
ARMADA, MACOMB COUNTY, MICHIGAN ORDAINS:

SECTION 1. BUILDING OFFICIAL DESIGNATED.

Pursuant to the provisions of the State Construction Code, in accordance with Section 8b(6) of Act 230 of the Public Acts of 1972, as amended, the building official of Armada Township shall be the enforcing agency to discharge the responsibility of Armada Township under Act 230 of the Public Acts of 1972, as amended. Armada Township assumes responsibility for the administration and enforcement of the State Construction Code Act throughout its corporate limits.

SECTION 2. DESIGNATION OF REGULATED FLOOD PRONE HAZARD AREAS.

The Federal Emergency Management Agency (FEMA) Flood Insurance study (FIS) for Macomb County, Michigan and Incorporated Areas dated September 29, 2006 and the Flood Insurance Rate Map(s) (FIRMS) panel numbers 26099C 0255G, 0256G, 0257G, 0258G, 0259G, 0263G, 0264G, 0265G, 0267G, 0270G, 0278G, and 0280G, dated September 29, 2006 are adopted by reference and shall serve as the official maps and supporting data establishing flood hazard areas for regulation by the Michigan Building Code and Michigan Residential Code.

SECTION 3. REPEAL OF CONFLICTING PROVISIONS.

All Resolutions, Ordinances or parts thereof in conflict with the provisions of this Ordinance are to the extent of such conflict repealed.

SECTION 4. SEVERABILITY.

If any section, paragraph, clause or provision of this Ordinance is for any reason held to be invalid or unconstitutional, the invalidity or unconstitutionality of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Ordinance.

SECTION 5. PUBLICATION

This Ordinance, or a summary thereof, shall be published in The Armada Times, a newspaper of general circulation in the Township of Armada, within thirty (30) days after its adoption.

SECTION 6. EFFECTIVE DATE

This Ordinance shall take effect thirty (30) days after its publication of a true copy or a summary thereof as provided in Section 5.

On September 13, 2006, the Armada Township Board enacted an ordinance to designate an enforcing agency for the state construction code, specifically the building official, to discharge the responsibility of the Township of Armada, under the provisions of the State Construction Code Act, Act No. 230 of the Public Acts of 1972 as amended, commonly known as the Stille-Derossett-Hale Single State Construction Code., and repealing any and all Ordinances and/or Resolutions in conflict therewith. The Ordinance becomes effective thirty (30) days from and after publication of this Summary.
