AMENDMENT OF ORDINANCE DESIGNATING AN ENFORCING AGENCY FOR THE STATE CONSTRUCTION CODE

ORDINANCE NO. 06-02A

TITLE

AN ORDINANCE of Armada Township to amend Armada Township Ordinance No. 06-02 to set forth the correct panel numbers of the Federal Emergency Management Agency Flood Insurance Study for Macomb County, Michigan and incorporated areas dated September 29, 2006.

THE TOWNSHIP BOARD OF THE TOWNSHIP OF ARMADA, MACOMB COUNTY, MICHIGAN ORDAINS:

SECTION 1. AMENDMENTS

Section 2 should be hereby repealed and the following substituted therefor:.

SECTION 2. <u>DESIGNATION OF REGULATED FLOOD PRONE</u> HAZARD AREAS.

The Federal Emergency Management Agency (FEMA) Flood Insurance study (FIS) for Macomb County, Michigan and Incorporated Areas dated September 29, 2006 and the Flood Insurance Rate Map(s) (FIRMS) panel numbers 26099C0040G, 0045G, 0065G, 0128G, 0130G, 0132G, 0134G, 0135G, 0136G, 0140G, 0145G, 0151G, 0153G, and 0165G, dated September 29, 2006 are adopted by reference and shall serve as the official maps and supporting data establishing flood hazard areas for regulation by the Michigan Building Code and Michigan Residential Code.

SECTION 3. REPEAL OF CONFLICTING PROVISIONS.

All Resolutions, Ordinances or parts thereof in conflict with the provisions of this Ordinance are to the extent of such conflict repealed.

SECTION 4. SEVERABILITY.

If any section, paragraph, clause or provision of this Ordinance is for any reason held to be invalid or unconstitutional, the invalidity or unconstitutionality of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Ordinance.

SECTION 5. PUBLICATION

This Ordinance, or a summary thereof, shall be published in The Armada Times, a newspaper of general circulation in the Township of Armada, within thirty (30) days after its adoption.

SECTION 6. EFFECTIVE DATE

This Ordinance shall take effect thirty (30) days after its publication of a true copy or a summary thereof as provided in Section 5.
