NO appeals will be heard at the organizational or final meetings. Due to health department restrictions ALL meetings will be held virtually.

All input received from members of the public prior to the meeting will be read into the record during the meeting.

The final ratio of assessments to true cash values as determined by the Macomb County Equalization Department is 50% for all classes of property.
