**TO THE QUALIFIED ELECTORS OF ARMADA TOWNSHIP:**

**PLEASE TAKE NOTICE** that any qualified elector of Armada Township who is not already registered, may register to vote at the office of the Township Clerk; the office of the County Clerk; a Secretary of State branch office, other designated state agency. Registration forms can be obtained at [mi.gov/vote](https://mi.gov/vote) and mailed to the Township Clerk. Voters who are already registered may update their registration at [www.expressSOS.com](https://www.expressSOS.com).

The last day to register in any manner other than in-person with the local clerk is **Monday, October 24, 2022**.

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at the Armada Township Clerk's office, located at 23121 E. Main, Armada, MI 48005 at the following times:

- **Regular business hours: Monday – Thursday from 9 a.m. to 4 p.m.**
- **Saturday, November 5, 2022 from 8:30 a.m. to 4:30 p.m.**
- **Election Day, Tuesday, November 8, 2022 from 7:00 a.m. to 8:00 p.m.**
