All precincts are handicap accessible. Voting instructions are available in alternative formats. Contact your Clerk's office for details. Please note that you will be asked to show ID when you check in. If you don't have one, you can still vote but will need to sign an affidavit of identity form if you do not have picture identification with you.

Accepted forms of identification: Michigan driver's license or state ID, driver's license or personal identification card issued by another state, federal or state government-issued photo identification, U.S. passport, Military ID with photo, student identification with photo from a high school or accredited institution of higher learning, Tribal identification card with photo.

**ELECTION DAY:** THE POLLS of said election will be open at 7:00 a.m. and will remain open until 8:00 p.m. of said day of election.

**PLEASE TAKE NOTICE** that you will be voting on nominating candidates for the office of the President of the United States and proposals listed below:

**Romeo Community Schools:** Building and Site Sinking Fund Millage Renewal Proposal and Operating Millage Renewal Proposal.
