CALL TO ORDER: 7:00 p.m. by Supervisor Paterek

OPEN PUBLIC HEARING: Paterek moved Swiacki second to open public hearing at 7 p.m. to receive requests for funding.

DISCUSSION: Clerk Swiacki stated CDBG funding for Armada Township for FY15 is 90,000. The following organizations requested funding: Care House \$550, MCREST \$1,575, Macomb County Warming Centers \$340, Macomb Homeless Coalition \$220, Macomb Literacy Partners \$1,000, Samaritan House \$3,000 and Turning Point, Inc. \$3,000 for a total of \$9,685. The remaining funds will be used to fund the Armada Senior Center Improvements – Parking Lot and Armada Township Senior Center Programs, Large Print Adult Books for the Armada Free Library. PAL is also included for funding. If it turns out that they are denied eligibility, it is recommended that those funds will go to program enhancements for the senior center. The township has been awarded \$41,500 from the Village of Armada CDBG funds to help fund the improvements to the senior center parking lot for a total of \$131,500 in CDBG funds.

Veronica Daffin – Macomb Homeless Coalition: Organization provides services and referrals to residents experiencing or at risk of homelessness. Runs the homeless management information system a data base of homeless persons being served by shelters. They have received 1.3 million in grants for the homeless shelters and housing programs.

Lynn McDonald – Care House: Each community's funding request are based on service projections in that community. They provide child-friendly, family-centered investigation, prosecution and treatment services to incomeeligible child victims of sexual and physical abuse.

Carrie Nickelson – Turning Point: Provides immediate emergency shelter, crisis intervention, and supportive services for survivors of domestic abuse and their dependent children 365/7/24. They also have a crisis line. Provides advocacy 24-hour crisis intervention, childcare, legal help, support groups, medical support, employment and housing searches and child support programs. They are asking for \$3,000.00
