### **NEW BUSINESS:**

**2015** Romeo 2 Richmond half marathon: Paterek moved Swiacki seconded approve resolution to allow the Romeo 2 Richmond ½ Marathon Race Route to proceed across road crossings that intersect with the Macomb Orchard Trail on September 20, 2015.

**Senior Center parking Lot – Award contractor:** Swiacki stated that we received \$108,000 in C.D.B.G. funds for the project. \$11,300 is for engineering fees, leaving \$96,700 and a shortage of \$2,450 that the township would have to pay. Supervisor asked about contingencies not listed in any contract. Clerk's office will contact Spalding DeDecker. Supervisor would like to have \$7,500 extra to cover additional expenses if any. Swiacki moved Goetzinger seconded to award project to Superior Contracting Group, LLC for the Armada Senior Center Parking Lot Improvements for \$99,150.00 as recommended by Spalding DeDecker.

**McPhall Rd. & Boardman properties – suggestions for use:** Board discussed leasing to farmers. Assessor will designate land as agricultural so no school taxes would have to be paid. We still have to pay taxes on property unless it is designated for township use like a new hall. No action at this time.

**Advertise for snow removal:** Swiacki moved Goetzinger seconded to advertise snow removal for a three-year contract from November 1, 2015 through October 31, 2018. **Motion CARRIED** 

Blake's Special Land Use Permit: LeMieux stated that the permit was approved by the Planning Commission last week and has been forwarded to the board for approval. Supervisor stated he spoke with Paul Blake to have him sign a letter because there were questions about signage on property and whether or not it fell into our sign ordinance. After consultation with planner and Paul they will sign an agreement that no signage would be changed or modified beyond this point without a permit. If they want to change or add anything, they will have to come and pull a permit for sign ordinance. Supervisor stated that the signs that are on the property existing, which we now have record of are grandfathered to the property.

Swiacki moved Smith seconded to approve Special Land Use Permit for Blake's Orchard & Cider Mill as presented and to have Blake's sign an agreement regarding current signage on property.
