DISCUSSION:

Clerk Swiacki stated CDBG funding for FY12 is \$38,000.00. The county has allocated an additional \$5000 to each community from a previous County set-aside that cannot be used for the intended use bringing our funding from \$33,000 to \$38,000. Of that \$30,000.00 goes to the Fire Department for a multi-year contract from 2007 to 2021. The county is still waiting for HUD to provide the actual grant amounts so what is provided is still tentative.

The following organizations requested funding: Armada Community Enrichment Program (ACEP) - \$1,000.00, Armada PAL - \$500.00, Armada seniors - \$3,000.00, Care House - \$500.00, Community Housing Network, Inc. (CHN) – no designated amount, Hope Center in Macomb – \$500.00, Macomb County Rotating Shelter Team (MCREST) - \$1,000.00 and Samaritan House - \$2,000.00.

Judy Barron - Samaritan House is a non-profit organization out of Washington, Michigan. Samaritan House has a food pantry and provides some assistance with shut off notices. Last year they assisted 2760 basic needs transactions that took care of 767 people. They give them three meals a day for 10 - 14 days. She works every Friday. Anything you can give they would appreciate any support. Judy invited anyone to come and visit the Samaritan House.

Chet Decker – Hope Center has hosted 24,083 client visits representing 65,084 people fed with just over 2,000,000 Pounds of food distributed. Their intention is to provide a full range of services to clients in an easily accessible location. They have a 27,700 square foot facility staffed with four full time and two part-time paid staff along with over 950 registered volunteers and operates at 7% overhead, so that \$.93 of every dollar goes to provide services to clients.

Clerk Swiacki read a letter from ACEP Director Sherri Cooper requesting funding to our low to moderate income Armada Township families to be able to participate in some of the ACEP activities with a scholarship.
