CORRESPONDENCE/INFORMATION:

Synthetic marijuana update: Swiacki stated that late Tuesday the Senate concurred with the amendments made by the House to SB1082 and sent the Bill to Governor Snyder's office for signing. People 'in the know' expect that it will be signed into law within hours. The Bill makes it a felony, punishable by up to 4 years in prison and \$20,000 fine to sell k-2, spice, 'bath salts' or products with an ingredient containing schedule 1 substance. In contrast, violations of Township ordinances are misdemeanors, punishable by 90 days in jail and a \$500 fine.

DEQ Complaint: Supervisor Paterek reported that no DEQ violation was located at 15655 33 Mile Road.
